Payment of States' share of net proceeds of all shareable Union Taxes and Duties on Fourteenth Finance Commission's recommendations payable to the State Governments due in October, 2016.

Sir,

I am directed to convey the sanction of the President of India for payment of ₹ 40738.78 crore (₹ Forty Thousand Seven Hundred Thirty Eight Crore and Seventy Eight Lakh only) as indicated in column 10 of the enclosed statement being the payment of States' share of net proceeds of all shareable Union Taxes and Duties on Fourteenth Finance Commission's recommendations payable to the State Governments due in October, 2016.

From the above amount, you are requested to adjust all outstanding amounts on account of defaulted repayments to Department of Economic Affairs/Department of Expenditure due from the State Governments to the Centre and the balance after adjustment of the outstanding dues may be paid to the State Governments in cash.
