Payment of States' share of net proceeds of all shareable Union Taxes and Duties on Fourteenth Finance Commission's recommendations payable to the State Governments due in July, 2015.

1 am directed to convey the sanction of the President of India for payment of ₹37426.08 crore (₹ Thirty Seven Thousand Four Hundred Twenty Six crore and Eight Lakh only) as indicated in column 10 of the enclosed statement being the payment of States' share of net proceeds of all shareable Union Taxes and Duties on Fourteenth Finance Commission's recommendations payable to the State Governments due in July, 2015.
