**CHANGE IN TARIFF VALUE OF RBD PALMOLEIN, POPPY SEEDS, ARECA  
NUTS, GOLD AND SILVER NOTIFIED**

**New Delhi: June 29, 2013**  
**Ashadha 8, 1935**

In exercise of the powers conferred by sub-section (2) of section 14 of the Customs Act, 1962 (52 of 1962), the Central Board of Excise & Customs (CBEC), being satisfied that it is necessary and expedient so to do, hereby makes the following amendment in the notification of the Government of India in the Ministry of Finance (Department of Revenue), No. 36/2001-Customs (N.T.), dated the 3<sup>rd</sup> August, 2001, published in the Gazette of India, Extraordinary, Part-II, Section-3, Sub-section (ii), vide number S. O. 748 (E), dated the 3<sup>rd</sup> August, 2001, namely:-
